

New Bachelor of Science degree in Homeland Security and Emergency Preparedness

Thomas Edison State College recently launched a new Bachelor of Science degree program in Homeland Security and Emergency Preparedness.

The 120-credit degree is offered completely online and was developed by a team of professors and practitioners to provide students with a broad view of homeland security issues by going beyond a single discipline to consider policy, preparation, response and recovery issues.

"This degree is designed for working adults interested in developing

the fundamental knowledge of homeland security and emergency management. Students will develop expertise in the day-to-day decision making required in the field, whether it is in a large city, a rural or suburban community or on a college campus," said Dr. Susan Davenport, dean of the Heavin School of Arts and Sciences. "The program also helps students position themselves for professional growth within private corporations, law enforcement and intelligence agencies, and other organizations."

Course work covers law enforcement, emergency management and business continuity issues. The degree compliments the Master of Arts in Liberal Studies or Master of Science in Management degree programs at Thomas Edison State College.

College Expands Partnership with Energy Providers Coalition

Thomas Edison State College has expanded its partnership with the Energy Providers Coalition for Education (EPCE) to include an undergraduate certificate in Gas Distribution.

The 15-credit certificate is offered completely online and can be applied toward the Bachelor of Science in Applied Science and Technology degree program, including students who select the energy utility technology or technical studies area of study.

Course work combines an overview of gas utility construction, operations and maintenance with regulatory and economic impact, incident investigation and the principles of management to provide a well-rounded understanding of gas distribution.

"This anticipated utility workforce shortage will create incredible demand on the energy workforce," said Dr. Thomas Devine, associate dean of the School of Applied Science and Technology. "We designed this program with a panel of industry experts from EPCE's membership to directly address industry requirements and are excited to be able to provide this program at a time when workforce development is so crucial."

New Course Format for Students Coming Soon

homas Edison State College is preparing to launch its latest format for course delivery, a new mobile learning platform that enables students to complete courses with little or no Internet connection.

Beginning in spring 2009, the first courses of Thomas Edison State College's *Mobile Learning Initiative* will be made available to students. These new courses will be called FlashTrack courses, and will take their place alongside of the College's other offerings, such as online courses, *e*-Pack® courses and Prior Learning Assessment. These courses will be delivered to students on a single 2 gigabyte (GB) flash drive – a device smaller than a pack of qum – and contain the same

structure and functionality of typical online Thomas Edison State College course.

"Our mobile learning platform will give students more flexibility to do their course work while commuting, on military deployment, sitting on the beach or in any instance where Web connectivity is not convenient or immediately available," said Dr. P. Henry van Zyl, vice provost, Center for Directed Independent Adult Learning at Thomas Edison State College. "It recreates the online experience in an offline setting."

The *Mobile Learning Initiative* is being made possible with funding from the Thomas Edison State College Foundation.

"Through the generous contributions of our alumni, students and friends, the Foundation is able to provide funding for programs like the Mobile Learning Initiative that leverage the latest educational technologies to provide more options for our students," said John Thurber, executive vice president of the Thomas Edison State College Foundation.

PHASE ONE

The first FlashTrack courses will enable students to complete the course without an Internet connection. These

initial 14 FlashTrack courses will prepare students to take a pass or fail final exam, which will determine whether they earn credit for the course.

Roll-out for students is scheduled for April 2009.

Flash drives that contain the first FlashTrack courses will come to students with everything preloaded to complete the course, including all course materials as well as the software necessary for word processing and spreadsheets, media players, PDF and photoviewing programs, and e-mail and Web utilities for students with access to the Internet.

"The flash drive acts in much the same way a computer hard drive does, but it is portable, secure, reusable and completely self-contained," noted van Zyl.

PHASE TWO

The second phase of FlashTrack courses involves converting additional College courses to be made available through a flash drive.

Van Zyl said the portability and integrity of the flash drives will be an attractive option to deployed military personnel, mass transit riders and busy adults who are mobile more often than they are at a stationary location.

"The flash drives are completely secure," he said. "There's nothing left behind on the host computer – all personal and course information is isolated on the flash drive, which students take away with them."

The devices are compatible with both PCs and MACs, so students using the new format can go from computer-to-computer, or device-to-device, completing and saving their course work each time without leaving a digital footprint.

LEVERAGING THE SMARTPHONE

In addition to FlashTrack courses, the College's *Mobile Learning Initiative* includes courses that can be accessed through smartphones, such as the Blackberry, the Palm and the iPhone, that can access the Internet.

These courses will enable students to use their smartphones to download multiple choice quizzes and submit their answers directly to the College. The College anticipates that *e*-Pack® courses will be the first to leverage this technology.

Initially, the College expects to offer 10 new courses that leverage smartphones by spring 2009.

"From a outreach standpoint, the College will also be able to transmit term calendar reminders, surveys, alerts, course news and updates to targeted student audiences instantly," said van Zyl.

TWO GRADS FROM '08 OVERCOME ADVERSITIES TO REACH THEIR GOALS

Thomas B. Lewis III and Amber Kreuter can tell you about challenges and fate. Both valiantly rose to the former and refused to accept the latter.

Lewis, BA '08, of Mt. Laurel, N.J., did not let blindness stand in the way of achieving his personal vision.

"I was born with cerebral palsy 34 years ago and am legally blind, and it looked like the path in my life was set," he recalled. "But when I visited my sister's music teacher, he must have seen something in me. Since I didn't have the dexterity for trombone, sax and guitar, he put a set of drumsticks into my hands – and I was home."

Later, Lewis took up the keyboard and with the help of local musician John Rivera, he learned to combine his

keyboard with a home computer software program. The pair eventually produced a disc that is raising funds to help families with disabilities.

After Lewis earned his associate degree from Burlington County College, he was encouraged to enroll in Thomas Edison State College by a mentor at the New Jersey Commission for the Blind.

"My sole purpose with my music is to enlighten the listeners and let them know that dreams are possible – and not just for children," he said. "The College gave me

the flexibility to achieve more. I learned the discipline and patience that sustains me in my work."


Like Lewis, Amber Kreuter, BSHS '08, of Pennsauken, N.J., also completed her degree while managing extraordinary challenges.

"While I had always hoped to complete my degree, tough times and family responsibilities forced me to put my education on the back burner," recounted Kreuter.

"Later, when I obtained my position as a director at Over the Rainbow preschool in Philadelphia, I realized that state regulations would demand that I obtain a college degree. Also, as a child from a family where no one had even graduated high school, earning a degree became a personal goal."

That goal would not be simple. Kreuter was faced with overwhelming obligations and earning her degree seemed hopelessly out of reach.

"With two children, a disabled husband and a job that required 60-plus hours of my time per week, I needed a program with a lot of flexibility," she said. "Thomas Edison State College met, and exceeded, all my expectations."





Lewis and Kreuter joined nearly 400 graduates from 28 U.S. states, including Alaska, who received their diplomas at the College's 36th Annual Commencement ceremony, which took place on Oct. 11 at The War Memorial in Trenton, N.J.

Two individuals addressed the graduates at the event.

Robert Boccolini, BA'08, of Marlton, N.J., gave the response for the

graduates. Boccolini, who is a court reporter, said members of the Class of 2008 have all overcome challenges to achieve their goals.


"We stand before you today as individual men and women who have decided that they would not allow their circumstances, their fears or their situations to stop them from fulfilling their dreams," he said.

Boccolini quoted Mark Twain to

conclude his remarks.

"Twenty years from now, you will be more disappointed in the things you didn't do than with the things you did do. Throw off the bow lines, sail away from the safe harbor, and catch the trade winds in your sails. Explore. Dream. Discover."

Entrepreneur and philanthropist Sydney Sussman, founder of Certified Steel and Nexus Properties,





received an honorary degree of Doctor of Humane Letters and gave a heartfelt message to the graduates.

"I think there are about 400 people here who should be up on stage beside me, receiving the degree I am receiving," he said. "You are reaching to new heights. You are reaching to the future. There are no guarantees, but I will give you some advice. Never quit. There is no such thing as a problem. There is only the absence of a solution."

The College awarded more than 2,400 degrees in 2008 and has awarded more than 32,000 degrees since it began providing flexible, high-quality, collegiate learning opportunities for self directed adults in 1972.



Like Father, Like Son

Russell MacArthur did not have to search the audience to see his father when he accepted his college degree. His dad, Glen, was right by his side.

Both men, of Washington, N.J., received their Bachelor of Arts degrees during Thomas Edison State College's 36th Annual Commencement in October. For Russell MacArthur, a Hunterdon County Post Office employee who aims to become a federal postal inspector, the jubilation of earning his college degree is two-fold.

"I'm very proud of my dad because of where he came from," said MacArthur. "Odds were against him. He went directly into the Army at a very young age and earned his GED while serving his country. He provided the support system to me that he never had, and what he has accomplished is amazing."

The elder MacArthur is now a vice president at Telcordia Technologies and holds two U.S. patents for voice over internet protocol.

If it was tricky for his father to navigate up the ranks of telecommunication industry in the 1980s without a degree, it was impossible for the younger MacArthur, who entered the workforce years later – without a bachelor's degree.

Not surprisingly, MacArthur said it was his father who provided an inspiration to work harder at completing his degree.

"At Thomas Edison State College, I really began to pick up the pace with course completion after my dad enrolled after me and started earning such high grades," he said.

Troy Vincent, BA '07, former NFL Pro Bowl player and Trenton native, recipient of the 2008 Spirit of Edison Distinguished Alumnus Award.

Joan Verplanck, president of the New Jersey Chamber of Commerce, recipient of the Spirit of Edison Community Leader Award.

Eric Lear, managing partner at Lear & Pannepacker, LLP, in Princeton, recipient of the Spirit of Edison Family Award. Lear is only the sixth person to ever receive the Spirit of Edison Family Award, which recognizes an individual's extraordinary

contributions to Thomas Edison State College.

Dr. George A. Pruitt, president of Thomas Edison State College, said this year's honorees exemplify the commitment to innovation, concern for the public good and spirit associated with the mission of Thomas Edison State College and the inventor for whom the school is named.

"We are honored to recognize individuals of such tremendous distinction this year," said Pruitt. "Troy, Joan and Eric have each made extraordinary contributions to their communities and in their respective fields. They are an inspiration to us all."

TROY VINCENT, BA '07

A 15-year NFL veteran, Troy Vincent, BA '07, was an All-Pro defensive back who has made powerful contributions and leadership on and off the field for the Miami Dolphins, Philadelphia Eagles, Buffalo Bills and Washington Redskins. As one of the most respected players in the NFL, he has served as the president-elect of the National Football League Players Association. Vincent was the only athlete to receive the NFL Walter Payton Man of the Year, the Sporting News #1 Good Guy, the NFL Players Association Byron "Whizzer" White Award and the NFL Athletes in Action Bart Starr Award. He has been recognized for his lifetime achievements from several organizations, including the New Jersey General Assembly and Pop Warner. In addition, Vincent was recently inducted into the University of Wisconsin Hall of Fame.

Vincent takes pride in his successes not only as a former professional athlete, but also in his civic and business leadership endeavors. He has ownership in several companies, including Eltekon and Pro Athletes Only, and founded the Love Thy Neighbor Community Development and Opportunity Corporation with his family. Vincent serves on the Board of Directors for the University of Wisconsin Foundation, and the New Jersey After 3 program.

In addition to earning his Bachelor of Arts degree from Thomas Edison State College, he studied Urban and Regional Planning at the University of Wisconsin and has completed executive education and business management programs at Stanford University, the Wharton School of the University of Pennsylvania, the Kellogg School of Management and Harvard Business School.

He resides in Virginia with his wife and five children.

JOAN VERPLANCK

Joan Verplanck is president of the New Jersey Chamber of Commerce, a 97-year-old Trenton-based business advocacy organization. Since her election in 1995 as the chamber's first female president, she has represented the business community on a wide range of critical issues.

Verplanck was instrumental creating the New Jersey Chamber of Commerce Foundation, which was established to build a highly qualified workforce through innovative collaborations with K-12 education and the workforce training and preparation system.

An officer of the foundation, she provides guidance and resources that enable programs that motivate students to be better prepared for college and life and improve employment opportunities for qualified individuals with disabilities. Several programs of the foundation are nationally acclaimed and are being used or replicated by organizations around the country.

Verplanck is widely considered one of the state's most influential business leaders and the recipient of numerous honors, including the Alan Daniels Civic Responsibility Award from the Center for Civic Responsibility; the Lewis R. Applegate Outstanding Business Leader Award by the New Jersey Society for Environmental, Economic Development; the Barbara Boggs Sigmund Award for Women of Vision; and the Virginia Apgar Award.

She was appointed by Acting Gov. Richard Codey to the New Jersey Employment Security Council and serves on the executive committee of the U.S. Chamber Foundation and Nation's Port. Prior to accepting her position with the New Jersey Chamber of Commerce, Joan spent eight years as the first female president of the Morris County Chamber of Commerce and 10 years managing chambers of commerce in Rhode Island.

ERIC LEAR

Eric Robert Lear is a managing partner at Lear & Pannepacker, LLP, a regional public accounting firm which he founded in 1984.

A 1979 graduate of Rider College, Lear has more than 30 years experience in accounting and specializes in strategic planning for small and family owned businesses to multimillion dollar corporations, customized personal financial planning and reporting for goal assessment; real estate transactions; and tax planning and tax compliance for all entities. He is licensed as a Certified Public Accountant in New Jersey, Pennsylvania and New York, and serves the tax interests of an international clientele as well.

His professional affiliations include the American Institute of Certified Public Accountants, the New Jersey Society of Certified Public Accountants and the Pennsylvania Institute of Public Accountants. Lear was awarded a certificate of educational achievement in personal financial planning as well as a certified specialist in management consulting.

Lear has always believed in serving the community that supported him throughout his career. He currently is active as a board member, finance and investment committee chair and treasurer with the Thomas Edison State College Foundation. Alumni Join the Charge to Help Fight Funding Cuts for Higher Education in New Jersey

Thomas Edison State College alumni have joined the charge to support New Jersey's state colleges and universities through their participation in the New Jersey College Promise Action Network.



The recent call to action resulted in more than 2,800 messages being sent to state leaders urging them not to reduce funding for higher education. In the past three years, New Jersey has divested hundreds of millions of dollars from higher education.

At Thomas Edison State College, the cuts in funding have brought its state support to the level it was 10 years ago.


Pamela (Jackson) Tafili BSAST'04
